### 1.0 Introduction

---

This policy statement sets out the school's arrangements for managing the access of providers to pupils at the school for the purpose of giving them information about the provider's education or training offer. This complies with the school's legal obligations under Section 42B of the Education Act 1997 and follows the guide outlined by the eight Gatesby benchmarks.

---

### 2.0 Pupil Entitlement

---

All pupils in years 7-13 are entitled:

- to find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point;
- to hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships – through options events, assemblies, group discussions and taster events;
- to understand how to make applications for the full range of academic and technical courses

- From Y7-13 six encounters with approved practitioners of apprenticeship and technical education (KS3-5).

**For pupils of compulsory school age these encounters are mandatory and there will be a minimum of two encounters for pupils during the ‘first key phase’ (year 8 to 9) and two encounters for pupils during the ‘second key phase’ (year 10 to 11). For pupils in the ‘third key phase’ (year 12 to 13), particularly those that have not yet decided on their next steps, there are two more provider encounters available during this period, which are optional for pupils to attend.**

These provider encounters will be scheduled during the main school hours and the provider will be given a reasonable amount of time to, as a minimum:

- share information about both the provider and the approved technical education qualification and apprenticeships that the provider offers
- explain what career routes those options could lead to
- provide insights into what it might be like to learn or train with that provider (including the opportunity to meet staff and pupils from the provider)
- answer questions from pupils.

### **Encounters with Further and Higher Education at WHSS.**

WHS students will encounter several meaningful experiences with a range of post-16 and post-18 learning opportunities.

All year 10 students and upwards will attend College taster sessions and open days. These will be local to where they live and local to WHS. Evidence is all on each of our student’s individual tracker sheets.

All year 10/11 students will have meetings with Apprenticeship providers at these colleges.

Those for who it is appropriate, will attend a Huddersfield University Visit in September.

Kirklees Apprenticeship Event (John Smiths Stadium) – February each year

SEND Careers event (The Leeds Arena) - June each year

Whole school Careers event in July – Army attending to talk about Apprenticeships and training in all of the Armed forces.

Year 7 students – A Careers event at Brighouse High in January (One university ambassador and 2 apprentices)

Year 8 students – A Careers event at Brighouse High School in October (At least 2 education and training providers will attend)

Senior Assemblies throughout the year – 2023 – We have had an Apprentice from Kirklees College Apprenticeship scheme and a talk from Appris Manufacturing and Engineering Apprenticeship provider.

### **Previous providers**

In previous terms/years we have invited the providers from the local area to speak to our pupils.

### **Destinations of our pupils**

Last year our year 11 pupils moved to a range of providers in the local area after school:

94% of all students entered achieved an Entry Level qualification in Step upto English, Maths & Science.
46% of all students entered achieved a Functional Skills L1 qualification in English, Maths & ICT
79% of all students entered achieved a Functional Skills L2 qualification in English, Maths & ICT
100% of all students entered achieved a GCSE qualification in Maths and Art

All students went on to study further qualifications at a local college.

Last year our year 13 pupils continued with their studying at local colleges to further develop their skills
